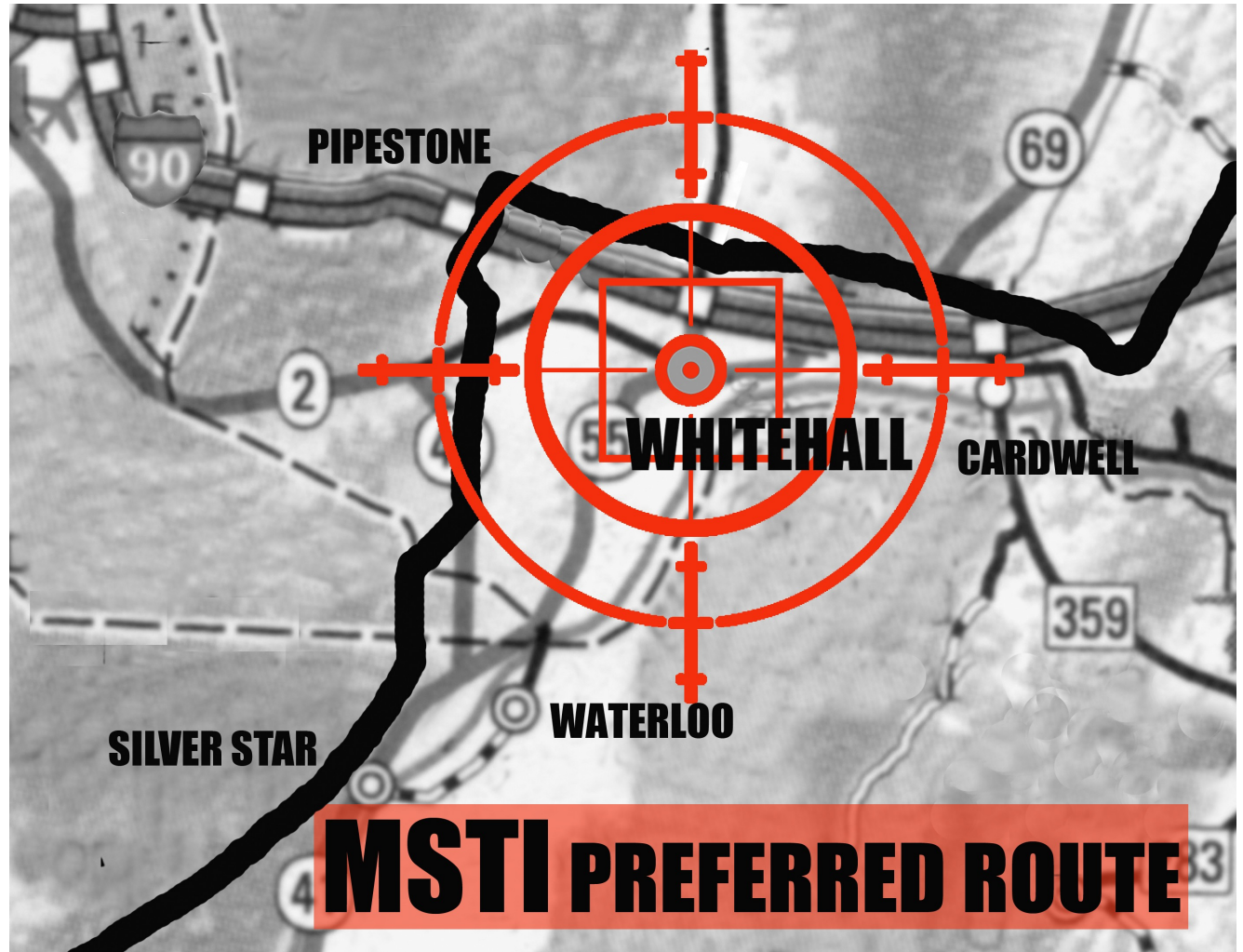


Just leaked, MSTI has found its target: US!
